CHAPTER 10-1 PLUMBERS AND ELECTRICIANS WHO WORK FOR THE CITY

10-1-1 SURETY BONDS

All plumbers and electricians desiring to do work in connection with the City water works shall furnish the City with a surety bond in the sum of two thousand dollars (\$2000.00) approved by the City Council, to protect, indemnify and save harmless the City of Hosmer from all and any loss, claim, suit or damages, direct or consequential, the said City may sustain by reason of the violation of any rules or regulations that may be enforced after having filed said bond.

10-1-2 LICENSING PLUMBERS

Upon presentation of a receipt for a fee to be determined by resolution of the City Council for said payment to the Finance Officer, the said Finance Officer shall issue to the plumber a license permitting him to do work on any and all pipes connected with the City mains, under and pursuant to all rules and regulations then or thereafter enforced, for the period of one year.

10-1-3 LICENSING REQUIREMENTS

No license shall be issued as aforesaid unless the applicant furnish the City Council with reference and convince that he has the ability and qualifications of a first class plumber.

10-1-4 REVOCATION AND RENEWALS

The City Council reserves the right to revoke and annual said license in case of any violation of the rules and regulations governing the management of the City water works. Said bond and license hereinbefore described must be renewed each and every year ending April 30th.

ADOPTION OF NATIONAL PLUMBING CODE

There is hereby adopted by the City Council for the purpose of establishing rules and regulations governing plumbing as defined in the Code, including permits and penalties, that certain plumbing code known as the "National Standards Plumbing Code" as adopted by the American Standards Association, being particularly the edition thereof, and the whole thereof, excepting such portions as are hereinafter deleted, nullified, or amended, of which a copy is on file in the office of the City Finance Officer of the City of Hosmer, and the same is hereby adopted and incorporated as fully as if set out at length herein and from the date of which this ordinance shall take effect, the provisions thereof shall be controlling pertaining to plumbing, as defined in the code, within the corporate limits of the City of Hosmer.

TITLE AND SCOPE

- A. TITLE. This Code shall be known as the National Standards Plumbing Code, may be so cited, and will be referred to in this ordinance as the Code.
- B. SCOPE. The provisions of this Code shall apply to govern plumbing as defined in the fixtures used in the installation, maintenance, extension and alteration of all piping, fixtures, appliances and appurtenances, in connection with any of the following: sanitary drainage or storm drainage facilities, the venting system, and the public or private water supply systems, within or adjacent to any building or other structure or conveyance; also the practice and materials used in the installation, maintenance, extension, or alteration of the storm-water or sewage system of any premises to their connection with any point of public disposal or other terminal.
- C. FACILITIES. It is recognized that certain facilities in or adjacent to public streets are referred to in this Code only a portion of which is under the ownership or the control of the owner or occupants of the building or premises to which this Code applies.
- D. ADMINISTRATION AND ENFORCEMENT. The administration and enforcement of this Code shall be the duty of the Building Official who is hereby authorized to take such action as may be reasonably necessary to enforce the purposes of this Code. Such persons may be appointed and authorized as assistants or may be necessary to carry out the provisions of this Code.

ADOPTION OF NATIONAL ELECTRICAL CODE

There is hereby adopted by the City of Hosmer for the purpose of establishing rules and regulations governing electrical work as defined in the Code, including permits and penalties, that certain electrical code known as the National Electrical Code, the most recent addition and also the Rules of the South Dakota State Electrical Board of which a copy of said code and Rules shall be on file at the office of the Finance Officer of the City of Hosmer, and said National Electrical Code and Rules of the State Electrical Board are hereby incorporated as fully as if set out at length herein and from the date which this ordinance shall take effect, the provisions thereof shall be controlling in the corporate limits of the City of Hosmer.

INSPECTION

The administration, enforcement, and inspection of all electrical equipment and installations in the City of Hosmer shall be made by the State Electrical Board and inspectors appointed by them.
